# **Risk Management**

This program offers insight on underlying risks that could exacerbate or trigger a claim for the world of A/E/C professionals. We will examine non-technical risk drivers from closed claims that incurred a loss or expense over a recent 5-year period. To gain further perspective on the areas of risk, we delve into the elements of risk within each risk driver. These 30 elements break out the non-technical actions, behaviors, or breakdowns in project or practice management that have resulted in a Loss Prevention file or a claim.
