6. Status of KDOT Funding & Update from Calvin and Burt Morey

Funding is good. Motor fuel tax has stabilized. State budget has reduced transfer by \$68 M.

Looking at scenarios for stimulus so KDOT can be in best position to utilize. Includes modernization and expansion.

Discussion of when KDOT and FHWA will be back in building due to pandemic.

7. Bureau of Local Projects Update; Mike Stringer

Staffing updates. Judith Tyner has retired. Dave Northrup hired as PM.

Program updates on Off System Bridges: HRR: CCLIP. Able to add additional funding or projects to each.

FAST act expires September 3<sup>rd</sup>. Anticipates reauthorization.

LRSP: Signing up counties. Would appreciate encouragement of Counties to sign up.

8. FHWA Update; Rich Backlund

FHWA currently teleworking.

RAISE discretionary grants open until July 12. \$1 B available. Applications have more stress on safety, environment and climate change.

# 10. Bureau of Road Design Update: Scott King

Pushing Tworks and IKE project to completion.

Any new project after Oct 1 will require new Bently work space.

Updating specs on polyester polymer bridge deck overlays due to issues.

Availability of resin has been an issue and has led to extreme prices.

Commercial traffic up 2-14%.

March revenue up from previous year.

Budget process in June.

Have put projects back on books that were delayed.

Beginning transition to cashless tolling.

Issuing RFP for roadside toll collection system.

April traffic up 55% compared to last year.

Discussed personnel changes. Kyle G. now GIS. Tim Burton replaced Dan V.

Discussed they may expand imbedded support.
